



RULES AND REGULATIONS ABOUT OPBU OFFICIALS & SCORING SYSTEM

- OPBU will use for its titles only officially registered and best possible trained professional officials;
- Beside OPBU titles, officials can do service for promoter for the rest of the program without extra compensation;
- There will be 3 judges, referee and supervisor chosen by OPBU in consultation with the national or another international sanctioning body involved in particular show;
- OPBU board of directors will choose the supervisor who will be obligatory present on the show where OPBU title is taking place;
- OPBU supervisor can take position as supervisor for world organisation who are the official partner of OPBU (WBC MT, KOTR);
- OPBU supervisor is also chief referee and his word is final. He brings all official papers, belt and certificate;
- During victory ceremony, OPBU supervisor together with the promoter or VIP guest is awarding champion with belt and certificate;
- OPBU supervisor will have to collect for officials, all taxes and travel expenses by promoter day before fight, during official weight in. Also, OPBU supervisor will have to collect all fight money and travel expenses for the fights who are under OPBU jurisdiction by promoter day before show, during official weight in or latest the same day but obligatory before beginning of the show;
- All payments according to the agreements and signed contracts will be done by supervisor to the officials and fighters immediately after their fight or at the end of the show;
- After the fight, OPBU should send supervisor's report to OPBU with his remarks about promoter, fights, official and show in general;
- Normally, OPBU will try to use independent officials but in order to help promoter with his expenses, OPBU can agree to use two judges from the countries where fighters are coming from + one neutral judge, referee and supervisor. Of course, if OPBU has licenced officials in neighbour countries he will try to use them;
- In certain situations, officially registered title could be also fought with two judges, referee who is also judge and obligatory supervisor;



- OPBU officials uniform will be: black sport shoes, black trousers or skirt, black shirt with OPBU logo on left side, red papillon and black blazer. Referees will have to use obligatory medicine gloves - possible black if not then white;
- OPBU supervisor uniform will be: black shoes, black trousers or skirt, white shirt with OBU logo on left side, tie and black blazer;
- OPBU officials will use " 10 point must system " on official OPBU scoring cards;
- OPBU title fight can be finished by following decisions:
 - on points by unanimous decision
 - on points by majority decision
 - by KO or KKO
 - by TKO
 - by abandon due to injury and medical intervention
 - by disqualification
 - draw
 - technical draw
 - no contest
- 3 knock downs in one round or 4 knock downs in whole fight, fighter loses the fight by **TKO**;
- 3 official warnings in one round or 4 official warnings in whole fight, fighter loses the fight by **Disqualification**;
- In case that no intentional foul happens in first 2 rounds, fighter could get up to 5' rest to continue the fight. If he can't continue, the fight will finish **NO CONTEST**. If the decisions by referee and official doctor are that he can continue but he refuses, fighter loses the fight by **TKO**;
- In case that no intentional foul happens after 2nd round, fighter could get up to 5' rest to continue the fight. If he can't continue the fight, final decision will be made by going on **score cards** till that moment, including actual round. If the decisions by referee and official doctor are that he can continue but he refuses, fighter loses the fight by **TKO**;
- Bell can't save the fighters in any round;
- **FOR THE FIRST TIME IN THE WORLD** - after 3rd round, OPBU supervisor will announce publicly to all present in the sport hall the actual situation on scoring cards;
- **FOR THE FIRST TIME IN THE WORLD** - supervisor is the only person in charge to take away negative points for Knock Down and Official warning. Judges will count only who was for them better fighter in that round, no matter on knock downs or official warnings;
- **FOR THE FIRST TIME** - referee will use yellow card for official warnings and red card for disqualification in order to make clear to all present about his decisions
